


SISCOMEX is the Brazilian Integrated Foreign Trade System and is short for "Sistema Integrado de Comércio Exterior". It is used to register foreign merchandise transactions (imports and exports)

This system, which was originally created in 1992, allows the government to have full supervision of international trading in Brazil and enforce current and new laws that are applicable to international trading. We are in full compliance with the International Chamber of Commerce (ICC) French: Chambre de commerce internationale), which is the largest, most representative business organization in the world. Its 6 million members in over 100 countries have interests spanning every sector of private enterprise.
